Representatives of the RHCAW continue to meet on a bi-weekly basis with the Health Care Authority (HCA) regarding reconciliation concerns as well as incorrect payments received by the Managed Care Organizations for the clinics who opted into Encounter at Time of Service payments.

2011-2013 Reconciliation update: There are only about 14 clinics that are incomplete. The Health Care Authority has requested the Office of Financial Recovery to cease recoupment actions, at this time, but may continue efforts in the future. If you need additional assistance please email fgchrhc@hca.wa.gov.

2014-2017 Reconciliation update: The Health Care Authority has reported they have not received any completed reconciliations. However, they have received many questions and requests for enhancement information. Reconciliation data is due to the HCA before the end of March. At this time the HCA is not requiring you submit overpayments at the time you submit your reconciliation information. We are hopeful there are no major issues however, if you do end up with major issues please contact the Krystal Guzman at kguzman@islandhospital.org or the HCA at fgchrhc@hca.wa.gov

2018 Encounter payments at time of service: We believe each MCO has been able to process or reprocess claims to pay encounters correctly. If you are still having claims after May 1 process incorrectly OR you have claims prior to May 1 which were paid incorrectly and NOT been reprocessed please send an email to fgchrhc@hca.wa.gov with specific claim examples. They will contact the MCO and work one on one with them to get these claims paid correctly. We have been notified that secondary claims after a commercial insurance are being paid incorrectly. Please gather examples and send to fgchrhc@hca.wa.gov. Please send an email to kguzman@islandhospital.org as she is also working with the HCA and MCO's regarding this issue.
